## RULES AND REGULATIONS.

2. Name :- Sri Channabasaveshwara Swamy Rural Education Society

3. Regd. Office of the Association. : B.H. Road, Gubbi

3. MEMBERSHIP :-

All persons who have attained 18 years of age and have subscribed to the aims and objects of the association subject to the approval of the Executive Committee, will be entitled to be its members and by paying of their subscriptions as hereinafter provided.

a) There shall be following classes of members besides Founder Members :-

i) **Life Members :-**

A person who is admitted to the membership of Association will be enrolled as "life Member" upon a single payment of subscription of Rs. 3,000/-

ii) **Member :**

A person who is admitted to the membership will be enrolled as Member upon a single and minimum payment of R. 1,000/-

Further they shall pay annual subscription Rs. 200/-

iii) **Patron / Honourary Member**

A person who installs special interest in the organization and function of the institutions, renders, technical, financial support, imparts spiritual, professional advice, will be enrolled/ conferred upon him /her, patron or Honourary Membership of the Organisation.

- b) Applications for admission should be addressed in writing to the secretary and should imply adherence to the Rural and Principles/ objectives adopted by the society so also the decisions of the Executive Committee.
- c) Applications for membership shall be submitted by the Secretary to the Committee at earliest meeting. For admission to the membership of the society the applicant must obtain unanimous approval of the committee.
- d) The decision keeping membership in abeyance or rejection shall be conveyed to the applicant in writing at the earliest, without ascribing reason thereof.

6. REMOVAL / CESSATION OF MEMBERSHIP.

The membership of the association shall cease upon a resolution of the committee that name of such member may be struck off the rolls. A member shall be removed from membership for non-payment subscription or for other grave reasons attributed by the Executive committee, unanimously. He/ her is however at liberty to make an appeal for revision of such decision at the next ordinary General Meeting. No member shall be removed from membership unless he has been previously called upon to give an explanation. The decision of removing a member from the membership shall be

communicated to him/her in writing besides making him/her liable for action as per section 19 and 20 of Karnataka societies Registration Act. 1960.

7. RECEIPTS AND COLLECTION OF FUNDS

- a) All funds received shall be utilised for commencement, addition, development of the Institution.
- b) Funds are to be collected for the proper conduct of this institution in the manner of donations, gifts, aids, grant, contributions etc., through different sources, from Governmental institutions/Board/Corporations, from individuals or organizations etc.,
- c) Funds are to be raised by arranging benefit schemes/performances and appeals, if found necessary and desirable
- d) Receipts in cash or kind are to be made or accepted in the name of the association or on its or on its behalf.

8. EXECUTIVE COMMITTEE :-

- a) The administration and Management of the Association shall vest in the Executive Committee consisting of the following.
  - 7 persons at present. The total number of Directors shall not exceed 15 persons.
  - 1) Chairman
  - 2) Secretary cum Chief Executive Director
  - 3) Treasurer
  - 4) Directors.
- b) The Members of the Executive Committee shall be elected from amongst the Honourary and Founder Member, Life Member and Members at a General Body Meeting of the Honourary and Founder Members, Life Members and Members.
- c) The Executive Committee shall amongst themselves elect office bearers : -
  - 1) Chairman
  - 2) Secretary cum Chief Executive Director
  - 3) Treasurer
- d) Term of office – the office bearers and members of the executive Committee shall be elected as per the directions of Managing Committee elected at the time of General Body Meeting
- e) The Executive Committee shall look after, take decision and act upon on the following matters :-
  - i) Introduce new service motivated and oriented schemes.
  - ii) Start Institutions and organize its functioning
  - iii) Initiate required action for development of institutions in different spheres.
  - iv) Formulate rules and regulation internal management and purpose to the General Body for ratification.
  - v) It shall ensure to carry out the decisions of the General Body.
  - vi) It shall administer all current matters and the secretary, in general is responsible for executing its governance.
  - vii) The Committee shall decide on matters relating to amendment to the rules and Regulations and proposal to the General Body at its annual or extraordinary Meeting for approval.

- viii) To appoint , promote, retain , take disciplinary action suspend or dismiss any employee for Managing and Functioning of association and to regulate their terms and conditions of employment including remuneration. And also frame subsidiary byc-laws for the said purpose.
- ix) The Executive Committee may appoint a Sub-Committee if required with such powers as deemed fit for the purpose of achieving the objectives of the association or to manage institution. The committee or sub-committee may coopt persons who are members of the association.
- f) The Committee shall have the power to vote the annual budget and also supplementary grants.
- g) The Committee shall decide on financial and functional arrangement with individuals and organisations.
- i) The Executive committee shall decide on matters regarding loans, purchases or investment on projects etc, beyond a certain sum stipulated by the General Body at its Annual Meeting or extraordinary meeting
- h) Meeting of Executive Committee
- i) Statutorily atleast once in month the meeting of the committee shall take place.
- ii) At such time as the secretary thinks necessary to convene it.
- iii) The Chairman shall chair the meeting or any office bearer/member in his absence, can preside over the meeting.
- iv) The quorum for the meeting is the presence of 2/3<sup>rd</sup> of office Bearers and Members.
- v) The Committee shall in the spirit of understanding and unity strive to take decisions on all matters unanimously. If not it shall be decided on majority votes. In case of equality of votes, Chairman shall have the power of casting vote.
- K) Special Invitees.  
Special invitees shall Participate in the deliberations of the Executive Committee Meeting and however, they do no have the power of casting vote.
- L) Vacancy and fill up of the post in the Executive Committee.
- i) The post of office Bearers of Members will become Vacant on account of resignation, physical or mental incapability, death etc.,
- ii) The Executive Committee elects the office Bearers amongst themselves in case if such vacancy arises. The Chairman nominates office Bearer or a member in Accordance with the Karnataka societies Registration Act -1960.
- K) The rights of custody, maintenance, utility of the properties movable and immovable is vested with the executive committee or sub-committee formed for the purpose.

## 9. GENERAL BODY MEETING :

- a) The final decision on the policy matters or ratifying the decision of the Executive Committee on important matters is taken by the general body meeting.
- b) General Body Meeting is convened by the Secretary once in a year.
- c) Patrons, life members, members shall participate in the meeting
- d) It shall elect Executive Committee once in two years.
- e) It shall approve annual expenditure and approve Annual Report.
- f) It shall approve the auditors report of the audit of books of accounts of the association by the Chartered Accountant.
- g) Any other matters placed in the meeting with the approval of the President.

## 10. SPECIAL GENERAL BODY MEETING :

Special General Body meeting may be convened for the following purpose.

- (a) Any amendments in the Memorandum and Rules and Regulations of the Association as required under sections 9 and 10 of the Karnataka Societies Registration Act 1960.
- (b) Special General Meeting may be convened on requisition of the president, if the Executive Committee wanted it
- (c) If not less 1/10<sup>th</sup> of the total number of members of the association entitled to vote requisition in writing, special General Meeting may be convened.

The Executive Committee shall fix the agenda. Decision shall be made by majority of votes of the members present. Minutes of each meeting shall be present and signed by the office bearers.

## 11. OFFICE BEARERS OF THE EXECUTIVE COMMITTEE :

The following office bearers shall discharge the responsibilities without any Remuneration or consideration. The posts are therefore deemed 'Honourary'.

- I) Chairman
- II) Secretary cum Chief Executive Director
- III) Treasurer
- IV) Committee Directors - 4 members

### (i) Chairman :-

- (i) He is head of the Association and he shall make an overall supervision of the affairs of the association
- (ii) He will guide and assist the Executive Committee in the proper administration.
- (iii) He possess the rights of monitoring, suspending the members of the Executive Committee as per the rules and regulation of the association. He accepts the resignation of the members of the executive Committee.
- (iv) All the policies and programmes shall be formulated and implemented only through him.

### (ii) Secretary cum - Chief Executive Director :-

- (a) He convenes the Executive Committee Meeting

- (b) He presents Receipts and Payment accounts ,records and annual budget in the meeting.
- (c) He is responsible to the internal management and enforce discipline.
- (d) He shall supervise the adminiustration and activities of the institutions.
- (e) He shall make office correspondence on all matters with the Government and other offices ,individuals, organisations etc.,
- (f) He shall make the budget, evolve creative plans, schemes in different faculties.
- (g) He shall carry out the decision of the Executive Committee.
- (h) He shall undertake all suitable action in good faith for the well being and progress of the institutions.
- (i) He shall call for the meeting of the Executive Committee as and when deemed necessary and the General Body and the special General Body Meetings as per the rules with previous approval of the Chairman maintain the minute book and record all the proceeding of the meetings.

(iii) Treasurer :

- (a) He shall Collect subscription fees from the members.
- (b) He accepts donations, aid, grant, gifts etc., on behalf of the Association.
- (c) He maintains necessary records relating to finance.
- (d) He shall make all the banking transactions ,expenditure and obtain endorsement/rectification from the President or Secretary.
- (e) He shall operate joint Bank Account with President and Secretary or with the Executive Members nominated/designated for this.
- (f) He presents receipts and payments in the Executive Committee Meeting and seeks its approval/confirmation.
- (g) He shall be the custodian of all funds.

12. For alterations in Memorandum and Rules and Regulations of the Association sections 9 & 10 of the Karnataka Societies Registration Act -1960 shall be followed

13. Annual returns shall be submitted as per section 13 of the Karnataka Societies Registration act-1960

14. The specified fees shall be remitted to the Registrar of the Societies as per section 10(2) and 13 of the Karnataka Societies Registration Act.

15. The official year of the Society shall be the year ending on 31 March i.e., 1 April of previous Financial year to 31<sup>st</sup> March of next financial year.

16. The Books of Accounts shall be got audited from a Chartered Accountant every year and the report shall be presented before the Executive Committee and General Meeting and obtain approval.

17. A copy of the audited balance sheet, income and expenditure Account approval by the Executive Committee and General Body Meeting shall be filed with Registrar of Societies, annually.

18. For matters and things which have not been specifically provided for herein above, provision of the Karanataka Societies Registration Act-1960 and Rules framed there under shall apply.
