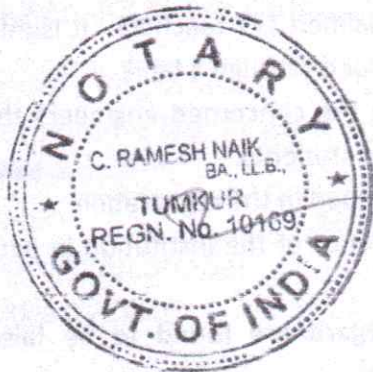

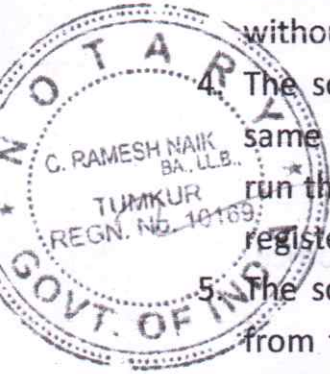

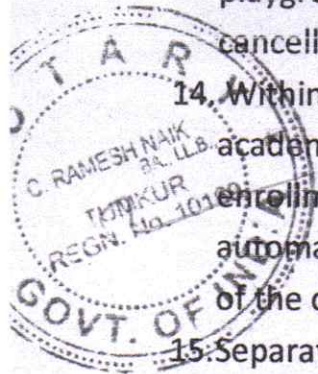

6. This high School Registration shall be permanent un-aided as per the Government Notification No.175:PMC:95, dated: 07-09-1998 and dated: 29-12-1998. The Governing Council should issue a consent letter duly sworn before the Notary on a Stamp paper of Rs.10-00 stating that they do not want any aid from the government.
